The homeopathic approach is very different from a conventional or allopathic approach. Unlike an allopathic approach, the homeopathic approach focuses on exploring the whole person. Homeopathy is not a disease-based approach. The homeopath explores the unique thoughts and experiences of each individual to uncover the basic causes and patterns of suffering. Then the homeopath chooses a homeopathic remedy, meaning a diluted & potentized substance, that best fits the individual state of the client. Thus it produces a deep healing, improved harmony and higher levels of awareness and enhances the capacity of the client to maintain an overall state of health and wellbeing based on nature's principle "like cures like".

The goal of homeopathy is to improve health and wellness in the most gentle and long lasting way. To assist the client in improving health and wellness and increasing energy, the homeopath must:

- understand the totality of what the client is experiencing that characterizes the individual's state; and
- find the homeopathic remedy most similar to that state.

The complexity of the information needed for homeopathic evaluation requires sufficient time to understand the state affecting the person's wellbeing – up to two hours for an initial consultation and a half hour for a follow-up appointment.

For some people the transformative journey with the homeopath is a shorter amount of time (2-3 months), and for others a longer period of time (up to a year or more). Ms. Kavitha Kukunoor schedules 4 – 8 weeks or quarterly (if required weekly) visits that are tailored to the specific needs of the client. The length of time homeopathy takes is dependent on the nature and duration of the client state and the response to the homeopathic technique.

Ms. Kavitha Kukunoor will explore all aspects of a person's situation (physical, emotions and mental state) and will also try to understand at deeper level called as sensation level (advanced homeopathy) to match that to a homeopathic technique. She uses the latest techniques of homeopathy in her practice.

Please check with Kavitha Kukunoor if acute state is included in the initial and follow up fees. She encourages her clients to get in contact as soon as an acute state arises in order for homeopathy to provide the most benefit to wellness and increased energy and thus support the process of achieving a state of overall health.

The risks in homeopathy are extremely low, as most homeopathic remedies are highly diluted substances and do not contain any chemical substances (except sugar). Homeopathic remedies are noninvasive, stimulate the person's natural mechanisms, increase the body's resistance power and are tailored to the individual. There is the remote possibility of short-lived and mildly uncomfortable aggravations of an existing or previous state after a homeopathic remedy is taken. ## Fee Schedule

The rate for homeopathic consultation services is \$ 230 (includes 6-8 wks care & supply of remedies) (\$5 discount if paid by check) and extended Initial visit (includes 10-12wks care & supply of remedies) - \$280 (\$5 discount if paid by check)

Online Follow up visit (30-40min): \$95/hour (with no remedies) (\$5 discount if paid by check)

**In person** Follow up visit (30min): \$100/hour (with no remedies) (\$5 discount if paid by check)

Online Urgent 15min care: \$45 (with no remedies) (\$5 discount if paid by check)

**In person** Urgent 15min care: \$65 (with no remedies) (\$5 discount if paid by check)

Online Focus consultation - 1 hr (includes care upto 2-3 wks, remedies included) - \$160

**In person** Focus consultation - 1 hr (includes care upto 2-3 wks, remedies included) - \$175

Shipping and mailing remedies \$25-\$50

This includes time in the office, on the telephone, or in case study. Payment is due at the time of service. No insurance reimbursement can be expected for these services. The client is responsible for full payment of the charges for the consultation at the time of the visit (**Only Check or online pay**) and cannot expect any insurance reimbursement. Because some companies do have Flex Plans which will reimburse for homeopathic services, you should check any Flex Plan/Health Savings plan in which you are enrolled. Cancellations will be free of charge if you inform the office 48 hrs. before the appointment or in case of an emergency, otherwise \$50.00 fee will be applied.

Records of client visits and other transactions are confidential. Ms. Kavitha Kukunoor may, for purposes of providing services to you, discuss a case in a confidential manner with a professional peer, without disclosing any information by which you might be identified.
